The deadline for camp registration is Tuesday, June 8, 2004. Please complete forms EARLY!

When is "Rainbow Spirit" camp?

How much does camp cost?

Children's Camp Junior Leadership Camp Counsellor in Training

\$285 (Early bird fee of \$265 if paid by May 8, 2004)
\$225 (Early bird fee of \$205 if paid by May 8, 2004)
\$50 (for training weekend) An honorarium will be paid to the CITs at the end of camp

What is the Counsellor in Training Program?

This was a new program offered in 2003 for 17 and 18 year olds, which will run at the same time as the Junior Leadership Camp. This will be a training and fun program designed to move former Junior Leaders to an eventual role as camp counselor. An additional application form will be required and applicants will be interviewed. If selected, CITs will attend staff training sessions in June and will form an integral part of the staff team at Rainbow Spirit this year. Because there is additional training involved, the **deadline for CIT applications is May 8, 2004**. Forms are available by request. A youth who applies and is not selected may still attend camp as a Junior Leader by paying the additional fee. Only 4 CIT positions are available this year.

What if camp is full?

We anticipate that we may have a waiting list this year. <u>We are taking registrations on a first-come, first-served basis</u>. If camp fills up, we will start a waiting list. You will be notified upon receipt of your application form and fee whether your child is registered or on the waiting list. If wait listed, you will be notified as soon as space becomes available.

What is the cancellation policy?

Cancellations received on or before June 28, 2004 will receive a full refund less \$25 for processing. No refund will be given for cancellations received on or after June 28, 2004.

What is the NSF cheque policy?

If there are insufficient funds to cover a cheque written for camp fees, a replacement certified cheque, money order or cash in the full amount plus a charge of \$20 will be payable to the Family Pride Camping Association prior to attendance at camp.

When will information be sent about what to bring to camp, directions to camp, etc.?

A package of information will be sent to you after your registration is processed and your fee is paid. The package will include important information for campers, an equipment list, a map to the camp and a receipt for fees paid.

How can I apply for a subsidy?

You can make a request for a subsidy of a portion of camp fees by completing a subsidy form available by calling 455-0186 or by making a written request to the above address. We will send you subsidy information and a form to complete. The completed subsidy form and minimum fee must accompany your application form and be received **no later that June 1, 2004**. The minimum fee is based on household income. All information we receive from you is kept confidential. We will inform you by June 12, 2004 if any additional fee is required depending on how many subsidy requests we receive by June 1, 2004.

How do I receive another camper registration form for a second child or friend?
