Nova Scotia Dancing Population in November 2017:

- -- 290 registered dancers.

Regional Directors are asked to let their clubs know that the Marketing Committee is ready to assist clubs with their publicity and recruitment efforts. Some of the items available to clubs at no cost are:

- Tri-folds can be customized
- Rack cards can be customized
- Retractable banners for loan
- SRDFNS and NS Flag pins

The Marketing Committee is available to meet with clubs or assist them in developing publicity and recruitment plans.

Supplies of tri-folds and rack cards can be customized and made available to clubs for their distribution.

### **Bluenose RV Squares**

Bluenose RV Squares is unique in that it is the only NSDCA chapter east of Quebec. The membership is drawn from the existing population of square dancers who represent each of the SRDFNS Regions, and are also campers. An invitation has been extended to all camping square dancers to consider joining BRVS. Some activities which have proven popular are Poker Runs, Crib Tournaments, 'Yard' Sales, Bingos and Lobster Dinner.

BRVS has its own page on the SRDFNS website under 'Mobile Club' and is updated after each campout. Thank-you to Webmaster, Gary Welch, for creating and populating the BRVS webpage which lists the Club's Executive, contact information; newsletters; current campout schedule and pictures.

The rack card for 2019 is available for promulgation to Callers in all 3 provinces—NB, NS, and PEI, for distribution amongst their club members in hopes BRVS can expand its membership and encourage dancers to combine square dancing with camping.

### **Cape Breton Region** – No active clubs

### **Highland Region**

**Highland Squares** and **Mapleleaf Whirlaways** have only danced occasionally. No bookmarks were produced for this region yet.

### **Fundy Region**

Cumberland Twirlers received 1K custom bookmarks for distribution within their catchment area.

### **Central Region**

**Lake City Swingers**: 1K bookmarks were produced for this teaching club.

**Stardusters:** A committee, formed from the club's membership, to develop promotional material for distribution within the Club's catchment area is still active. The Club has had some success recruiting new dancers directly due to the distribution of their bookmarks. At their request, an additional supply qty. 1K was provided for distribution.

**Fun Squares**: Although this club had not been a member of SRDFNS for some years, another opportunity to keep square dancing active is lost with its closing.

### **South Shore Region**

LaHave River Ramblers: LaHave River Ramblers has closed.

**South Shore Squares:** South Shore Squares newly formed in January 2018, and is the only square dance organization serving the South Shore. SSS utilizes all resource materials: Banner, posters, bookmarks, rack cards and tri-folds, distributed throughout its catchment area. An additional supply of 1K bookmarks was produced.

### **Valley Region**

**Fundy Squares**: The largest club in the Valley Region, it has had some success through its advertising campaign which includes a permanent outside sign at Wilmot Community Centre, bookmarks and posters.

# SOUTH SHORE REPRESENTATIVES' REPORT SRDFNS EXECUTIVE MEETING 13 OCT. 2018

This report of the South Shore Representatives, covers the period April 14, 2018 to October 13, 2018.

South Shore Squares is the only active square dance organization on the South Shore and is registered with the CSRDS and member of SRDFNS. Paul and Cathy Langille carried out a promotional blitz in the form of trifolds, bookmarks, posters, 4 newspaper ads which ran in two weekly papers over 2 weeks and PSA radio announcements over CJQC-FM in Liverpool. In addition, some of the dancers have distributed promotional material in their area of residence/work.

CKBW has changed its PSA policy by offering special rates to nonprofit organizations. Due to limited funds available, no ad was placed with CKBW. We will explore possible ads with CKBW in the future.

It is also noted that although South Shore Squares' advertisements state 'square dance attire admired, but not required', several dancers have chosen outfits from donated items. Thank you to Ellen Pettipas and Wilma Illsley for helping the dancers assemble their outfits.

South Shore Squares has retained 11 of the original dancers who attended the January, 28 – April 13, 2018, session. Four new dancers began September 14, 2018, and 1 has dropped out due to illness. It is noteworthy that 1 youth has joined SSS and is learning Basic Level 1. Three former LaHave River Rambler couples have began attending this Fall's session. Laurie Illsley has been retained as Caller/Instructor.

Some SSS dancers consider square dancing a 'winter' activity and may choose to return in January, 2019.

SSS has taken preliminary steps for funding through the Federal Government's 'New Horizons' Program. Further followup is required once applications open again.

## **Mission and History**

Our mandate is to encourage, promote and support dance as a cultural, educational, social, recreational and healthful activity for Nova Scotians of all ages, abilities, and backgrounds.

### **Background**

DANCE NOVA SCOTIA is the umbrella service organization for all forms of dance in Nova Scotia. Founded in 1974 and incorporated in 1975, it is one of eight provincial cultural service organizations that comprise the Cultural Federations of Nova Scotia, which are funded by the province. Dance Nova Scotia is a registered charitable organization governed by a Board of Directors elected from the community.

# **Programs Include:**

- Providing educational resources to public schools, including the creation of instructional materials
  relating dance to Grades P 9 social studies, language arts and music curricula in Acadian and
  traditional Cape Breton dance, professional development for school teachers and library
  resources for dance in education;
- <u>PERFORM!</u>, a joint project of Dance Nova Scotia, Theatre Nova Scotia, and the Nova Scotia Choral Federation, which brings professional artists into the classroom to deliver workshops in dance, theatre, and music;
- Community-based networking and pilot programs to promote existing dance opportunities and to encourage the development of new dance programs where none have existed before. The most recent program to be implemented is BreakSpace, a free weekly breakdance drop-in session open to anyone. The session is followed by a practice session where members of the Urban Dance community drop in and not only participate but also act as mentors for young dancers;
- Providing services to professional dance artists and companies to assist with fundraising, grant writing, and promotion;
- Partnering with <u>Kinetic Studio</u> to present their Open Studio and First Ideas series, residencies with visiting choreographers and dancers, building mentorship opportunities, as well as presenting Taking Steps to Fly, a yearly showcase for young choreographers;
- Professional development for dance teachers with a strong focus on aging populations. Working to bring the latest developments in areas related to seniors and dance, as well as advances which support the benefits of dance for Parkinson's and dementia, through networking with organizations such as Canada's National Ballet School and Parkinson's Canada;
- Managing DANSpace-on-Grafton, a dance studio funded by the Nova Scotia Department of Communities, Culture and Heritage, making the space available to artists in all disciplines;
- Database of dance artists and dance teachers throughout the province. This search engine is accessible to everyone through our website;
- A library collection of over two thousand textbooks and instructional videos for choreographers, dance teachers and public school teachers;
- Developing workshops for artists, teachers and dance individuals on many areas of dance, business/administration and subjects of interest to members;
- Information on dance through our weekly e-news bulletins, as well as our (mobile accessible) website which includes extensive event calendars delivering information on dance activity across the province as well as our notice board (jobs, dance opportunities, etc).
